- 2. The Lumberville Aqueduct is in the process. NPS (Wild and Scenic, and National Historic Landmark team) had to be consulted about some changes in design. But all of the approvals have been made and that one is well underway.
- 3. Headquarters Road Bridge-DEP approves permit
- 4. Nockamixon Dam water release evaluation-drought
- 5. Paunnacussing gas line Mats have been removed and permanent fix is in the works
- 6. Fleecydale Rd NPS and PennDOT in consult about erosion repairs Ground Water Contamination

- 1. **Opening Activities** Richard
  - a. Approval of July minutes (no August meeting)
    - i. Bob made a motion, Mark second. Unanimously approved.
  - b. MC meeting on September 25
    - i. Focus on Expansion Study
    - ii. Summer debrief SC member and general discussion.

- 2. Expansion Study Update- Sarah
  - a. Municipal Support Update

- Robert McEwan has been leading the process for three years (thank you Robert).
- ii. Goal to revisit designation since it has been 25 years since original designation..
- iii. Community attitudes changed, less industrialization in areas and increased focus on the value of recreation.
  - 1. Some conversations are still taking place but the project is moving into the documentation phase.
  - 2. Goal of obtaining support to close most gaps and adding key tributaries likely to be met.
  - 3. Lower Delaware Expansion Committee, took summer off and will be invited to the MC meeting for updates.
  - 4. Shana Stewart-Deeds, consultant, working on Management Plan Amendment, basically the next generation Management Plan. Plan will highlight changes in the designation area as well as new areas
  - 5. Nathalie is now working on this project as well.
  - 6. Sarah shared drafts of maps for the project with GIS contract assistance from HC.

#### 3. Administrative - Alison

- a. End of Year Financials in Progress
  - i. Federal FY ending budgets in September. The next meeting will share an end of year report.
- b. New CA Structure
  - This year's initiative to get more consistency among CA orgs so started a new CA this year (submitted this summer, reflecting the budget developed last winter/spring).
  - ii. Last year of the current 5 year Cooperative Agreement to stretch into next FY.
  - iii. Remember that budgets were shared late this year, but fully funded.
- c. NPS Update Sarah
  - i. NPS lost a significant amount of staff in the last 9 months, especially in the PWSR program. Conversations taking place about potential ways to address.
  - ii. Projects: Looking at canal wall projects. Fleecydale Road is still a Penndot project. Private restoration project towards Carversville.

## 5. Partner Updates & Summer Experiences

- a. HLT- Jackie closed on 6 acres on the river, hits many LODE management goals. Started in 2021. Newsletter out with mentions of LODE. Announced that Catherine Suttle is stepping down as Executive Director, Emily Dunn will be the new ED.
- b. HC Matt A few properties in UMT and Williams to close in fall.
- c. NJ DEP Steph/Lauren Steph has been working on the September 20 cleanup. Thank you, Steph!
- d. Bucks Parks Angie emailed: Hal H. Clark is still in permitting with DEP and township.
- e. DRBC Amanda saw a lot of recreation decrease attributed to possibly the hot weather. Data centers are an emerging issue but none have applied for permits. Model working toward dissolved oxygen levels which is good for river health; DRBC has advised EPA rule.
- f. Bob-tubing seems to be better managed with the new parking lot which is managed by Big Bear. Richard-he did not see that parking lot full in the past two years.
- g. Alison-saw more private tubers than the past. The river was very unpredictable with levels, speed.

- i. Mark-looked at the report. Recited that they learned about it in Jan 2025, but it was reported in September 2023. Drilling recovery wells. It's a joint in the pipeline and there are 44 joints in the area, one failed. Paid for carbon filters on wells. Hints it went down hill. Senator Steve Santasario has been involved. Residents noted the smell of oil in the canal in summer and can see glistening in the water.
- f. Washington Crossing Bridge replacement.
  - i. Bob attended-DRJTBC and NJ Transportation meetings which highlighted the bridge project. Presented future project plans. Listed 5 projects (two Amtrak bridges and a 295 bridge). Amanda Bay was giving the presentation. Richard-design work can start 2027, looking to replace.
